## **Poll Results**



- ✓ Developed, launched in 2007
  - 70 institutions, 80 leaders
  - APLU and AASCU partnership
- ▼ Three objectives
  - Demonstrate accountability, transparency
  - College search tool
  - Support innovation in the measurement, reporting of student learning outcomes
- 288 participating public universities

## **VSA Origins**



- ☑ Brought national attention and focus to higher education and higher education outcomes
- ☑Re-stated the importance of higher education for the nation and for individuals across all demographic and socio-economic backgrounds

## VSA Origins: Spellings Commission Report



- "We urge the creation of a robust culture of accountability and transparency throughout higher education. Every one of our goals, from improving access and affordability to enhancing quality and innovation, will be more easily achieved if higher education institutions embrace and implement serious accountability measures."

## Components of the College Portrait



- ☑ HEOA compliant net price calculator
- ✓ Free for use by VSA participants, but not required
- ✓ Updates planned for Spring 2014 to provide more accurate net price estimates, clearer presentation of results

## College Affordability Estimator



- ✓ Alternative to federal 6-year graduation rates
- - Graduation or continued enrollment at the submitting institution
  - Graduation or continued enrollment at a subsequent institution
  - After 4 years & after 6 years

## Undergraduate Success & Progress Rates



- ▼Two required cohorts of students
  - First-time, full-time degree-seeking undergraduates
  - Full-time, transfer-in degree seeking undergraduates
- ✓ Starting with 2012-13 College Portrait, additional, institutionally defined cohorts allowed
  - Veterans
  - Low-income students
  - First-generation students

## **Poll Results**



- ☑ Responses to a single, scripted question asked of students about to graduate
- ☑ Can be administered stand-alone, or part of another survey
- ✓ Students can select all options that apply
- ✓ Response rate and administration details are required

## Future Plans of Bachelor's Degree Recipients



- Recent employer surveys endorse undergraduate research, study abroad, and internships as desirable in new employees
- ✓ Selected senior responses from one of four surveys is reported:
  - College Senior Survey (CSS),
  - College Student Experiences Questionnaire (CSEQ),
  - National Survey of Student Engagement (NSSE), or
  - Student Experience in the Research University (SERU)
- Results can be no more than 3 years old

## **Student Experiences**



- ✓ Original Student Learning Outcomes pilot project ended in 2012
  - Directly measure, publicly report learning gains (valueadded) using one of three tests
- **☑** Evaluated by NILOA in Spring 2012
  - Expand assessment tools, approaches
  - Focus on communication, specific audiences
- ✓ Expertise contributed by technical work group, communications advisory group, support team, VSA Board, input by VSA participants

## **Assessing SLO Pilot Project Effectiveness**



#### ■ Results from 1 of 4 instruments required

- AAC&U VALUE Rubrics for Critical Thinking & Written Communication
- ACT CAAP critical thinking and writing essay modules
- CLA performance and analytic writing tasks
- ETS Proficiency Profile critical thinking and written communications sub-scores

## **Student Learning Outcomes**



#### 

- Value-added (cross-sectional or longitudinal, testing first-year and senior students)
- Senior-only benchmarking (comparison to test publisher norms)
- ✓ Institutions report on administration process as well as use of assessment data and results in campus decision-making
- ✓ Student population and tested sample demographics are required
- Results can be no more than 3 years old

## **Student Learning Outcomes**



- ☑Pilot project wrap-up: VSA participants describe, publish pilot project experiences using three part form
- - 65 participated administered or tried to administer one of the instruments
  - 27 did not participate

## **SLO Pilot Experience Report**



## **27** institutions posted results to their College Portrait

- 16 found the results useful on campus
- CLA was the most frequently reported
- **238** institutions tried to administer an instrument
  - 14 reported difficulty meeting minimum sample size requirements
  - 8 reported campus concerns with sample sizes, even when they met publisher recommendations

## SLO Pilot Participant Experiences



#### 

- Campus perceptions that the instruments wouldn't provide useful results at 9 institutions
- 7 institutions has more pressing institutional priorities
- 6 institutions were concerned about the monetary cost of the instruments

## SLO Pilot Non-Participant Experiences



- ✓ Institutions asked to select all options under consideration by campus
  - 28 institutions considering more than one option
  - Many institutions exploring benchmarking and value-added for the same instrument
- 44 institutions considering the ETS PP
  - Either/both value-added, senior-only benchmark administrations
- **■34** institutions considering AAC&U VALUE Rubrics

- ✓ More effective delivery of information to key audiences
  - Evolve from college selection website to information tools for consumers, campuses

## Changes for 2013



- ✓ Project financially sound, self-sustaining
- ☑ Traffic to CP website at all time high up 40% since 2011, up 90% since 2009
- Accountability and transparency remain important at national, state level
  - VSA part of state, system accountability
  - Success and progress rate emerging as valuable alternative to federal grad rate
- ✓ VSA credited with advancing SLO work

- ✓ Form Communication Advisory Group from public affairs, communications, government affairs
- ☑ Re-connect with key audiences: assessment experts, state/system officials, accreditors
- ☑ Tailor the display and delivery of key data elements on College Portrait for key audiences

- ✓VSA Affordability Estimator improvements provide more accurate net price estimates, clearer presentation of results (February 2014)

## **Upcoming Releases**



- ✓ Unprecedented challenges for public higher education to be more accountable and more transparent concerning value, outcomes
- ☑ HEA re-authorization is looming (again)
- ✓ Work to position the VSA/College Portrait as a tool to respond to those challenges
